Nominations are now open for the CoM for 2019-20, and nominations are sought for the following positions on the Committee:

- Captain
- Five Ordinary Members.

Term of office

Each member of the CoM will hold office from the conclusion of the 2019 AGM until the conclusion of the 2020 AGM.

How to nominate

Complete the Nomination Form on page two of this document and return to the Secretary of the Club by **noon on Saturday 23 June 2018.**

How is the CoM elected?

- At the Club's Annual General Meeting on Sunday 28 July 2019.
- If only one nomination is received for a Flag Officer position that person will be deemed elected at the AGM. If only five nominations are received for Ordinary Members then they will be deemed elected at the AGM.
- If more than one nomination is received for a Flag Officer position or more than five nominations are received for Ordinary Members then a ballot will be held at the AGM.

How often does the CoM meet?

The CoM meets on the second Wednesday of each month at the Club at 7.30pm.
